Registration in the computer lists of the club

The French Law 2018-493 of 20 June 2018 on the protection of personal data (GDPR) now applies to associations.

To simplify, are considered as personal data all the information relating to a natural person identified or identifiable by his name, first name, photo, nominative email address, images, civil status, geolocation data, vehicle registration...

The purpose of this data within the Hotchkiss Club is to keep up-to-date a file of members and their vehicles to carry out mail-outs (Couriers, Juste Milieu, invitations, invitations to the General Assembly and others), ensure that replacement parts applicants are up-to-date with their annual dues, analyze and identify the members' fleet of vehicles to select the spare parts to be purchased or manufactured, allow access to the private portion of the club's website.

The recipients of this data are the members of the Board of Directors and the Regional Delegates. The data are kept ten years after the date of exit of the club. Until now, the data were kept in paper format. They are now computerized. The data officer is the president of the club.

All operations of this type, such as collection, recording, structuring, storage, extraction, modification, consultation, publication, provision, crossing, erasure, destruction, etc., are considered to be processing of this data. Any processing must be based on a legal basis, **in our case the explicit consent of the person concerned.**

Therefore, in order for the club to be in compliance with the law, we ask the members of the Hotchkiss Club to please give their consent, at the time of membership or when applying for renewal, by signing this document and returning it to:
